We provide civil legal assistance at no charge to low-income families with children, the elderly, veterans and people needing access to healthcare. The people we serve often live with the risk of losing something be it their home, job, health, safety or independence. We target people living in violence, people with an impediment to family stabilization, those who cannot find stable employment and families at risk for homelessness. Through the legal system, we can preserve the home, protect assets, stop the violence, remove employment barriers, and support families towards the goal of achieving maximum independence and safety. Last year we reached over 25,000 people, advocated for over 9,600 and provided legal representation to 18,258. Private attorneys donated \$314,600 in services to our clients.
