The people we serve often live with the risk of losing something be it their home, job, health, safety or independence. We target people living in violence, people with an impediment to family stabilization, those who cannot find stable employment and families at risk for homelessness. Through the legal system, we can preserve the home, protect assets, stop the violence, remove employment barriers, and support families towards the goal of achieving maximum independence and safety. Last year we reached over 74,378 people, advocated for over 9,800 and provided legal representation to 20,489. Private attorneys donated \$305,280 in services to our clients.
